- 3. (i) Even when there is a clearly defined project scope, you still have to beware of scope creep. Describe the main causes of scope creep. (10 marks)
 - (ii) Do you think managing scope creep in project management is unachievable? Explain with examples. (10 marks)
- 4. (i) As a project manager, you noticed during project execution that conflicts arise in the team on both technical and interpersonal levels. What are the appropriate ways of handling conflicts? Explain with suitable examples. (10 marks)
 - (ii) All stages of the project life cycle appear to be characterized by conflicts. Explain the nature of conflicts in different stages of the project life cycle. (10 marks)
