 - (II) Marthelis sets fire on some garbage in his garden and leaves the compound to have a cup of tea. The fire extends to the neighborhood and causes damage to Gabiriel's house. Gabiriel demands compensation for the damage.
 - (III) Justin is an employee of ABC Television Networks and has served the company for eight years. One day the manager of the company informs Justin that his services are no longer needed. Justin seeks remedy for wrongful termination.
 - (IV) The Education Ministry decides to make English the compulsory medium of education in all Advance Level classes of the country. Prabath and Jananthan who are two civil society activists think this decision is a violation of the rights of the citizenry.
 - (V) The police finds the dead body of Amali. Through investigations the police discovers that her husband can be suspected for murder. The chief of police seeks to initiate further action against the husband.

Mr. Lopez who is interested in antique dealings offers Sarala to buy the piece of furniture promising her a promotion. After knowing about this transaction, Sarala's father becomes agitated.
 - (III) Kithmini visits Hotel Benilia for a vacation. She checks into her room and after refreshing leaves out for coffee. Upon return she realizes that some of her valuables kept in the room are missing. The Hotel management refuses to take any responsibility. They refer to a notice displayed on the backside of the room door which states that the hotel holds no responsibility for any loss of valuables or damages to goods.
