

- Understanding the key components of language, including phonology, phonetics, 2.1 syntax, and pragmatics, is crucial for comprehending human language development.
- How does the distinction between phonology and phonetics contribute to our a) understanding of speech sounds and their functions in different languages? (5 marks)
- How does understanding syntax contribute to our comprehension of sentence b) (5 marks) formation and grammatical rules?
- How do speakers use pragmatic rules to maintain coherence and manage c) (5 marks) conversations effectively?
- Exploring Andy Clark's six aspects of language as a cognitive tool, along with the 2.2 contributions of Edward Sapir and Benjamin Whorf to the study of language and thought, provides valuable insights into how language shapes and enhances cognitive processes.
- Briefly explain Andy Clark's six aspects of language as a cognitive tool. How do these a) aspects enhance our understanding of the role of language in cognitive processes? (7 marks)
- How did Edward Sapir and Benjamin Whorf challenge traditional views in the study b) (8 marks) of language and thought? Explain
- Emma, a 4-year-old, and Liam, a 5-year-old, were observed for their language 2.3 development. Emma grew up in a bilingual English-Spanish household, while Liam was raised in a French-Arabic environment. Emma demonstrated balanced proficiency in both languages, often switching between them effortlessly. Liam, however, showed greater fluency in French and struggled more with Arabic.
- How does Noam Chomsky's concept of 'universal grammar' explain the similarities a) and differences in Emma's and Liam's language acquisition? Provide examples from (5 marks) their development.
- According to B.F. Skinner's theory, how does reinforcement influence the language b) (5 marks) skills of Emma and Liam?
- What are the limitations of Skinner's theory in explaining the complexities observed c) (5 marks) in Emma's and Liam's language development?
