2. According to Robin Lakoff, women use language that reinforces their own subordinate status.

Using this as the starting point of your answer, comment on how verbal interaction helps to maintain hierarchical relationships between men and women.

 "The interesting thing about pronouns is their close association with two dimensions fundamental to the analysis of all social life- the dimensions of power and solidarity." (Brown and Gilman)

Discuss the above statement with reference to pronoun usage in English and any other language that you are familiar with.

- 4. "...code switching has been studied ... merely as a linguistic phenomenon that takes place haphazardly..." (Senaratne, 2009)

 Would you agree with this view of code switching? Your answer should include references to code switching in Sri Lanka as well as other countries.
- 5. Tollefson (2002) comments that the traditional perspective of language planning assumes that policies are usually adopted in order to enhance communication: the critical perspective however explores the links between language policies and inequalities of class, region and ethnicity/nationality.

Discuss this comment in relation to the language planning activities of three (3) Asian countries, including Sri Lanka.
