 - I. Amal offered to sell 10,000 bricks at the rate of Rs. 25/= to Dhammika on the 5th of November. Dhammika accepted on the 6th of November. The price of bricks went up in the market on the 8th of November and Amal revoked his offer on the 9th of November. (7 marks)
 - II. Rohan agreed to design a computer programme to calculate taxes for Nawala Municipal Council. The programme was to be delivered in June. However, Rohan only delivered it in August. It was later discovered that the taxes which had been calculated manually during July were wrong and that the Council had lost Rs. 500,000 in taxes. (7 marks)
 - The Road Development Authority decided to build a highway from Nawala to Battaramulla. However instead of giving the contract to the company that was willing to do the job for the lowest price, they awarded it to Royal Builders who quoted a higher price as they promised to pay a 20% commission to the Chairman of the Road Development Authority. (6 marks)

5. Ranjan is the owner of 20 acres of land in Ja- Ela and has decided to build a large apartment and office complex. The construction was assigned to BICC Builders. Ranjan instructed BICC Builders that the complex should consist of eight apartment blocks, six office buildings, a hotel, and a shopping centre. BICC Builders has subcontracted with S&S Architects to design the complex. The design was approved and the construction had commenced. In the midst of construction the following incidents occurred.

Discuss the remedies available to the affected parties

- a. One apartment building and the parking garage adjoining the apartment collapsed. As a result, 50 construction workers died and 15 others were injured.
- b. A 5 year old child who came to play on the land fell into a trench and was injured.
